

## Waiver of Liability and Release

### Waiver of Liability and Release.

This Waiver of Liability and Release (hereinafter "Waiver/Release") is being signed knowingly, freely, and voluntarily in my individual capacity and in my capacity as the parent and natural guardian of, or the legal guardian of, \_\_\_\_\_ (hereinafter "Child), and on behalf of Child, and it is being signed in favor of The First Baptist Church of Trenton Florida Inc. and First Place Academy (the "Academy") First Baptist Church of Trenton, Florida Inc., (the "Church"), and their Faculty, Staff, Employees, Agents, and Volunteers, (hereinafter collectively referred to as the "Releasees"). I acknowledge that I am seeking to voluntarily enroll Child in the Academy located on the property owned by the Church and that the Academy's decision to accept Child for enrollment at the Academy is based in part on, and in consideration of, this Waiver/Release.

In consideration of the opportunities afforded me and my Child for my Child to be enrolled as a student in the Academy (including, but not limited to, all of the Academy's programs and activities and related services, whether academic, athletic, extended care, extra-curricular, or otherwise, and whether conducted during the normal operating hours of the Academy or after the normal operating hours of the Academy), and in further consideration of the privileges and benefits relating to such enrollment and participation in the Academy located on the property owned by the Church, I, on behalf of the Child, and individually, hereby release Releasees from, and waive against Releasees, any and all claims, expenses, compensation, demands, and causes of action, of any nature whatsoever, for any injuries, death, and damages of any nature whatsoever that might occur to Child or me from the date hereof and forward relating to or resulting from Child's enrollment and participation in the Academy and any of its programs and activities as referred to above. By way of explanation and not limitation, this Waiver/Release includes the waiver and release of any alleged negligent conduct (excluding any willful, malicious, or grossly negligent conduct) on the part of the Releasees

I acknowledge that prior to signing this Waiver/Release, I have been advised by the Academy to, and have had the opportunity to, consult with an attorney of my choice regarding this Waiver/Release and its full meaning and legal effect and am knowingly and voluntarily signing this Waiver/Release and agreeing to be bound by it. I further agree to indemnify and hold harmless Releasees from any and all damages of any nature, including, but not limited to, attorneys fees and costs of defense, in the event that any person or entity on behalf of me or Child seeks to void this Waiver/Release or otherwise seeks to make any claim or obtain any type of damages against Releasees which are otherwise waived and released as set forth above

We (I), being 21 years of age or older, do for ourselves (myself) (and for and on behalf of my child-participant if said child is not 21 years of age or older) do hereby release, forever discharge and agree to hold harmless First Baptist Church of Trenton/ First Place Academy, the pastors, the staff, and the directors thereof from any and all liability, claims or demands for personal injury, sickness, or death, as well as property damage and expenses, of any nature whatsoever which may be incurred by the undersigned and the child-participant that occur while said child is participating in any and all activities, work projects or trips.

Furthermore, we (I) [and on behalf of our (my) child-participant if under the age of 21 years] hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein.

The undersigned further hereby agree to hold harmless and indemnify said church/academy, pastors, its directors, employees and agents, for any liability sustained by said church as the result of the negligent, willful, or intentional acts of said participant, including expenses incurred attendant thereto. (If the said participant has not attained the age of 21 years).

We (I) are the parent(s) or legal guardian(s) of this participant, and hereby grant our (my) permission to take said participant to a doctor or hospital and hereby authorize medical treatment, including but not limitation to emergency surgery or medical treatment, and assume the responsibility of all medical bills, if any.

Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs. I also grant my permission for photos to be taken of my child and used by First Baptist or First Place to publish for promotion of events and church/academy activities.
